

# Tips for Accessible Educational Materials

## 1. Don't assume digital means accessible.

**We used to think** that if an educational material was digital it was automatically accessible.

**We now know** that digital content is not inherently accessible so we provide learners with customizable digital content - content they can personalize. **And we are noticing** that many learners (not just those with disabilities) are more engaged, have improved fluency and skills, and better comprehension when using content they can make their own.

## 2. Add “alt text” to images.

**We used to think** text was the only barrier in our curricular materials. **We now know** that images can create a barrier for learners who use screen readers, if an alternative means for perceiving the information in an image is not provided. **And we are noticing** that adding alternative (“alt”) text (e.g., “photograph of a moose crossing a road”) reduces this barrier and can help all learners better understand the relationships represented in the images.

## 3. Add closed captions to videos.

**We used to think** all learners could learn from videos. **We now know** that audio without accompanying text may create a barrier for learners who are deaf, hard of hearing or who are emerging bilingual learners so we add closed captions to video content. **And we are noticing** that lots of learners are using those captions for lots of reasons (e.g. viewing the video in a quiet setting, comprehension support).

## 4. Use styles for document structure.

**We used to think** that a document that appeared organized, with section headings created with the formatting options (e.g., making the text larger and bold), made the content easier to navigate and understand for all learners. **We now know** that section headings and other elements need to be created by assigning the proper styles (e.g., heading 1, heading 2, list). **And we are noticing** the table of contents created from these properly styled documents reveals how information is organized and improves understanding and navigation of long documents for all learners.

## 5. Use high contrast colors for text and background.

**We used to think** we could simply pick favorite colors, seasonal colors or our schools' colors for the fonts and backgrounds of the educational materials we created. **We now know** that when there is not enough contrast between the font color and the background color it can create a barrier for learners with low vision so we use high contrast color combinations (i.e. a light background with a dark color font). **And we are noticing** that our educational materials look bolder and sharper across varied devices for all learners - especially in harsh lighting where glare might be a problem.

## 6. Use more than just color and styling to highlight features.

**We used to think** we could use color or styling (bold, italics) to highlight key ideas and critical features in our educational materials. **We now know** that we cannot rely on visual style alone to convey meaning and that adding emphasis with text (e.g., “note” or “important”) is a better way to call attention to essential information. **And we are noticing** that decreasing our reliance on color or styling to highlight content has better supported many learners to find key ideas.

## 7. Use descriptive hyperlinks.

**We used to think** naming our hyperlinks “click here” was simple and supportive. **We now know** that this and other non-descriptive link titles create a barrier for screen reader users who may have to navigate through multiple hyperlinks in a single document to locate a resource, so we use descriptive links (e.g. “Project Guidelines”). **And we are noticing** that descriptive links support the executive function of learners who like to copy hyperlinked content into their class notes.

## 8. Use plain language.

**We used to think** that what was clear to the content developer was clear to the user. **We now know** that plain language is more accessible than sophisticated vocabulary and complex sentence structure. **And we are noticing** this plain language supports lots of learners (e.g. emerging bilingual learners, learners managing anxiety, learners managing fatigue) to deeply understand concepts and instructions more fully.

## 9. Use built-in accessibility checkers.

**We used to think** only accessibility experts were able to evaluate the accessibility of documents, videos and webpages. **We now know** that many authoring tools have accessibility checkers built in to make sure your work meets basic accessibility requirements. **And we are noticing** that even accessibility checkers get it wrong sometimes and the ultimate measure of whether content is accessible or not is how well it supports learners in reaching their goals.

## 10. Adopt principles for developing AEM.

**P.O.U.R.** is an acronym that supports educators who are creating and/or procuring educational materials to be sure they are accessible for the widest range of learners. POUR is a set of four principles presented as reflective questions:

- **P** Is the content **perceivable**?
- **O** Is the content **operable**?
- **U** Is the content **understandable**?
- **R** Is the content **robust**?
